- upholstered furniture
- bus seats
- school seats and tables
- textile floor coatings of all kinds
- elastic and rigid floor coatings made of wood, stone, PVC, linoleum etc.

Processing

Spray on WEICON Chewing Gum Remover for several seconds and from a short distance until the freezing effect can clearly be seen. Then remove the dissolved residues immediately from the surface with the attached spatula. Clean textile coatings with a vacuum cleaner or a brush after the use of WEICON Chewing Gum Remover. Caution: Danger of undercooling with contact to skin. Hold can strictly upright, do not shake. Press spray top in short intervals as required.

Storage

Pressurized container: protect from sunlight and do not expose to temperatures exceeding +50°C.
